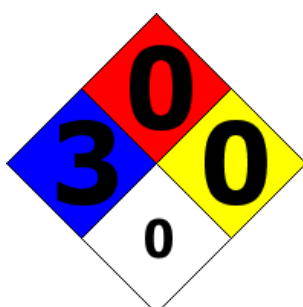

Irritation. Headache. Nausea. Shortness of breath.;

Hydrogen bromide gas. Container explosion may occur under fire conditions. Thermal decomposition can lead to release of irritating gases and vapors.

Appropriate Engineering controls:
